Regnart PTA Direct Donation 2011-2012

Regnart PTA supports an enriched educational experience for our children by funding important programs beyond the core offerings provided by the state. The PTA funds the Arts, Physical Education, the Library, and the Computer Lab at Regnart including this staff and other classroom instructional aides.

Our primary PTA fundraising program is a Direct Donation appeal to all Regnart families. **This year, the PTA is recommending a donation of \$220 per student for the year.** Statewide budget cuts have impacted public school funding including reductions in school support staff paid for by both district and PTA funds. Last year, the PTA recommended preserving the level of classroom services by increasing staff salary support to cover the district shortfall which underlies this year's \$20 increase.

In addition to paying for instructional aides and programs that directly benefit your children, the PTA also supports ongoing technology upgrades at school and popular community-building activities including Fall Festival, the Yearbook, and Family Fun events.

Direct Donation at Regnart raised \$115,000 in 2010-2011. We believe Direct Donation is a particularly efficient fundraiser since every dollar you donate benefits your children directly. Regnart PTA is a registered 501(c)(3) non-profit organization and **your Direct Donation is tax-deductible.**

We strongly encourage you to investigate **employer matching programs** at your workplace, which can double the benefit of your donation. Last year, Regnart received over \$7,500 in corporate match programs from Adobe, Applied Materials, Cisco, eBay, Google, Intel, Intuit, Juniper, Microsoft, nVidia, Oracle, SAP, Yahoo! and many others.
